ACCIDENT

Unanticipated event that results in an injury, illness, hazardous spill/release, or significant property damage

EMERGENCY

- Fatality
- Injury/Illness requiring medical attention
- Laboratory exposures
 - Chemical
 - Eyewash or shower used
 - Biological/Needlestick*
 - Animal bite/scratch
 - Laser
 - Radioactive
- Chemical spill OR oil spill
 - Hazardous/toxic
 - Too large for spill kit
 - Entered a drain
- Confirmed fire/explosion causing damage
- Significant property damage (Flooding in multiple rooms/levels, disruption to building operations)
- Odor complaint leading to building evacuation or multiple occupants struck ill

Critical step if emergency assistance is needed or event occurs after-hours
 4:30 pm – 8:00 am

INCIDENT

A close call/near miss that has the potential to escalate to accident status

NON-EMERGENCY

- Minor injury, first-aid was self-applied or medical attention was not needed
- Minor chemical or oil spill
 - Non-hazardous
 - Addressed with spill kit
 - Drain not impacted
- Incident occurred that had the potential to cause an accident
 - Equipment malfunction
 - Improper use of equipment
 - Contained fire, no damage
 - Fire extinguisher was used, no damage

EHS or ORS On-call Safety Officer begins root-cause analysis.

EHS or ORS initiates root-cause analysis within 24 hours of report.

SAFETY CONCERN

A routine safety issue, concern, complaint, or clarification.

ROUTINE

- Policy or regulatory clarifications
- Chemical storage, handling, or emergency procedures
- Indoor air quality complaints
- Mildew or mold concerns
- Job safety analysis/risk assessment

EHS or ORS assigns work request and responds to e-mail within 24-48 hours.

* For needle sticks, call the needle stick hotline immediately at 773.753.1880 pager 9990#.

** If you're located in an off-campus facility (e.g., Gleacher Center, Ricketts, Yerkes), please call 911 or follow the site-specific procedures during emergency situations (e.g., fire, ambulance).

FAQs

Q: Where can I submit a report?

A: Download theUCAIR mobile app (IOS or Android) or go to ucair.uchicago.edu to submit a report online and learn more aboutUCAIR. TheUCAIR link is also present on the websites of both safety offices (EHS and ORS).

Q: Do I need to login toUCAIR?

A: No. Anyone can access theUCAIR tool and submit a report.

Q: Can I report an accident/incident anonymously?

A: Yes. However, anonymous reporting is only for events that do not require medical attention. If a University employee sustains an injury requiring medical attention they must follow the Human Resources Policy 525 – Workers’ Compensation and complete three forms with their supervisor. If you are reporting a non-injury anonymously, please be as detailed as possible to ensure we can locate the area to determine the root cause.

Q: I work in a Medical Center building, does the process change?

A: Yes. Call Public Safety at **773.702.6262** to report all emergencies in the Medical Center and follow their reporting procedures. If you are a University employee, then you can submit a report using theUCAIR tool.

Q: If I submit a report toUCAIR, does it also notifyUCPD?

A: No. TheUCAIR tool only sends a notification to the main email boxes of the safety offices (EHS and ORS). In the event of an emergency callUCPD at **123** or **773.702.8181** to ensure proper emergency response procedures are triggered (e.g.,UCPD pages: On-call engineer, On-call Safety Officer for EHS and/or ORS, Dean On-call if students are involved, etc.).

FAQs

Q: Why should I useUCAIR?

A: YourUCAIR report will allow the safety offices to follow-up and determine the root cause of an accident/incident, which can drive change and eliminate future occurrences.

Q: What is the difference betweenUCAIR andUCARE?

A:UCAIR is a system for submitting a report about any accident/incident that occurs on campus or work-related injuries at off-campus locations. UCARE is the University of Chicago Alcohol Risk Reduction Education Program that is managed by Student Health and Counseling Services (SHCS).

Q: Does this replace the whistleblower hotline?

A: No. Please call the University's whistleblower hotline at 1.800.971.4317 to report unethical or inappropriate behavior.

Q: How do I know whether to report something?

A: All accidents/incidents should be reported no matter how minor. Reporting of accidents/incidents helps identify the cause and prevent future occurrences. If in doubt, report it.

Q: When should I not use theUCAIR system?

A:UCAIR’s main goal is to eliminate preventable injuries and significant accidents that impact university employees or disrupt facility operations on a large scale. Do not useUCAIR to report crimes, building maintenance issues, condensation, musty odors, mold/mildew, nor nuisance odors related to food/cooking. Contact Facilities Services or Physical Plant for all building related maintenance issues and the appropriate safety office for routine safety work requests. Contact Environmental Health and Safety for non-lab related issues and the Office of Research Safety for lab related issues.
